SD Guthrie has achieved **97.1%** Traceability to Plantation (TTP) in 2025 based on percentage volume of all products (Crude Palm Oil (CPO), Crude Palm Kernel Oil (CPKO), Palm Kernel (PK), Refined Palm and Refined Palm Kernel Oil (Refined PKO)) supplied to each of its refinery, biodiesel and palm kernel crusher ("KCP"):

Summary of the methodology

1. In 2025, the 14 above mentioned SD Guthrie facilities sourced their materials from 125 direct mills and 1325 indirect mills. For verification, 36 mills were selected for sampling based on factors such as volumes provided and number of deliveries.
2. Reported traceability figures by SD Guthrie for all the facilities are included in this scope and were reviewed by cross checking information for the mills selected for the sample and delivering to a specific refinery. Incoming delivery documents were reviewed and traceability score cross checked using the following formula: $(\text{Total traceable volumes per refinery} / \text{Total purchased volumes per refinery}) \times 100$.
3. A plantation was considered traceable when the following information were available: parent company name, plantation name, longitude and latitude coordinates, address/location (optional) and certification status (optional).
4. Control Union's responsibility was to exclusively verify the accurateness and completeness of the information as received by SD Guthrie methodology and processes for the calculation of the traceability scores for the facilities included in the scope
